Finalists may be invited to make oral presentations to the Board. The Board will evaluate applications based on the following criteria:

- Significance of the problem to be addressed;
- Innovative solution to the stated problem or issue as it relates to education and training of participants in basic life skills and family and consumer sciences;
- Objectives that are clearly defined and justifiable with outcomes that are realistic in terms of what is expected to be accomplished;
- Plan of action and activities that directly relate to the projects goals;
- Project is suitable to the age level and involves actual participant involvement;
- The economic need;
- A reasonable budget;
- Impact of the project on participants;
- Improve awareness to better prepare participants for their day to day life tasks;
- Help underachieving participants reach their potential;
- Feasibility of actually implementing the projects vision.
